Celebrating our 10th Anniversary!

s we come up to the 10th anniversary of FUNGIS it is worth reflecting on how it started and some of the original objectives.

FUNGIS first started on 3 March 1988 as a loose group of people with a common interest. From its inception in 1988 to 13 July 1990 three seminars were held but there were no formal meetings or office bearers.

The second recorded meeting was held on 13 July 1990 where ArcInfo and MapInfo sub-groups were formed and a steering committee given the task of formalising the group through incorporation. This meeting was attended by:

The steering committee consisted of:

This committee formulated a draft constitution and made a number of recommendations to a meeting on 10 A u g u s t 1990. The se recommendations included:

•The size and representation of the executive

- •That FUNGIS meet quarterly on the Friday of the second week of the appropriate month.
- •That newsletters be published quarterly
- •The size of the fees.

Following a meeting on 10 August 1990, application for incorporation as an association was lodged on 15 August 1990. The group was incorporated on 28 September 1990 and Barney Myers was appointed as secretary at a meeting on 15 October 1990.

The objectives of FUNGIS are:

- •To offer a forum for members to exchange knowledge, ideas and experience on GIS at a local level.
- •To act as a focal point for organisations and individuals to gain information about GIS from outside sources.
- •To provide a source of crossorganisational links for those with similar interests in GIS.
- •To promote the use and awareness of GIS to the wider community.
- •To provide a forum for discussion of policy issues in GIS and a body to represent the region in policy matters.

The constitution provides for both individual and corporate members who have been proposed and seconded by existing members. Corporate membership is open to organisations with an interest in the development of GIS within the Far North Queensland Region.

The constitution does not limit the

The Issues

Lisa has listed above, the main aims of this position. It has been created because it has been identified that there is a significant amount of spatially related information that has been captured but not documented and/or listed, particularly in North Queensland.

In recent years, there has been somewhat of an explosion in data acquisition with the rapid development in technology and improved data capture techniques. What has not kept up however, is the capture of adequate documentation pertaining to the information that now exists.

Some of the emerging issues for users with regard to the access and use of spatial information, as stated by Peter Wilson in his FUNGIS Newsletter item 'Data Sharing in Far North' 4th Quarter 1999, are "Gaps in data, formats of data, cost of data, custodial legalities, data access hoops and just knowing what data exists are a few of the impediments...."

FUNGIS LAUNCHES NEW LOOK WEBSITE

Can you imagine seeing a Ferrari Testarossa in the fast lane on one of Germany's infamous autobahns, doing 25 K/hr, crunching gears, doing the kangaroo hop with the windscreen wipers working on a sunny afternoon and being driven by a 12 year old girl? Well...that's how I felt when asked to create a web site on the superhighway with a \$1000 worth of software I've never seen before. I had to get there in two weeks and it wasn't going to be pretty!

According to folklore, the first FUNGIS web site was published by Uts Wellbrook in the early to mid 90's, I never saw it, (Web access was restricted to managers who were the only ones informed t o bе wwwdothootersdotcom) so I had nothing to compare this site with. But I've seen enough bells and whistles on other web sites to know the standard was up there.

Creating a web site from scratch, begs the first question. "Where do I start?" Lisa came up with the idea of those basic questions, Who?, What?, Where? and When?. Answer those and you've got it half finished. I think "Benefits" was thrown in because we all want to get something out of being a member of FUNGIS.

People read newspapers to find out what's news. They read books and magazines to acquire information and knowledge. The content of a web page is the combination of all of the above. The content of the fungis web page represents us, the

The Benefits To You – Your First Question - "What's in it for Me?"

I will talk in terms of "what is in it for me" because I understand the demands we all have on time and resources these days and that only those issues that have a direct significant and immediate impact on our activities tend to get addressed.

Identifying what information exists, therefore, is critical to using and enhancing your own data and making information more easily accessible to users (even within your own organisation. National Metadata Guidelines have been developed by ANZLIC to standardise metadata capture.

The next steps in resolving any of these issues above are for you -

- 1. for you to be able to effectively catalogue and manage the data you have (your assets) and
- 2. for you to know what other data exists that is available and suitable to enhance your data for your business needs.

This starts with Metadata. Metadata is data about data ie. a description of the characteristics of data that has been collected for a specific purpose.

Here is the irony though, if your access to land information is to be

maximised, adequate descriptions of the characteristics of <u>all</u> geographically referenced datasets must available. No matter who you are or where you work, this essentially starts with <u>your</u> datasets.

In discussions I have had with some of you to date, it seems that you are already aware that this needs to happen and understand the reasons why.

The Metadata Coordinator

This role (12 month temporary) is the first of its type to be created in Queensland. My role is to coordinate and provide assistance wherever possible for you capture your metadata.

While it is clear what results are required, the various activities I will need to undertake in assisting you may vary depending on your needs. These will become clearer and evolve as I talk with you. I will commence however by undertaking the following activities—

- Setting up effective two-way communication with you to identify what your needs and issues are and take action to remove any hurdles.
- Gain the necessary support from your senior managers.
- Assist spatial data custodians in
