Congratulations! You have an executive who have been willing to allow extreme personal scrutiny so we can continue to use Paypal for members' online security and convenience.

We have now submitted three years of required Annual Returns to the Office of Fair Trading, and a search of their web site will show that we now appear there again as a valid incorporated association. We have also met the requirements of the Australian Taxation Office's Not for Profit Reforms

The Exec has been very conscious of and diligent about the need to comply with the Fungis Constitution and has been establishing procedures for appropriate ways of doing things to ensure transparent accountability.

For six months of the last year the Fungis Exec continued to pay for administrative assistance – as you will see from the Treasurer's Report a paid administrative position wasn't financially sustainable. So when the administrative assistant resigned, Anne Stapledon as secretary and Rahman Schionning as treasurer, who had already been doing a lot of voluntary work, increased their workload. They have done a tremendous job and Fungis owes them a vote of gratitude.

Workshops

The Fungis calendar year, which goes from the 1st of May to the 30th of April, started with the 2011 LiDAR Technologies 2011 workshop, which was an outstanding success. Presentations from this Workshop were posted on the Fungis website.

A nautically themed Fungis FunDay that incorporated the 2011 AGM was held on the 39th of July.

The FunDay started at the Great Barrier Reef International Marine College where the staff demonstrated the simulated spatial training facilities for ship navigation, and allowed some of us to have a go – good fun! Then there were the very interesting and informative talks which were later posted on the Fungis web site.

GIS Day was celebrated in conjunction with our 2011end of year event. We had lunch together at Dunwoody's Tavern, Esri provided GIS day goodies and Team Peever provided compasses. After our lunch and executive meeting we benefited from some web training from Alistair Hart and, of course the opportunity all important for some networking.

The guest speaker at our 2011 end of year event was David Hine from Land and Water Management who gave a very beneficial presentation on how to convince managers about the benefits of GIS and spatial technologies.

In past years when the Exec has asked members about the direction they would like to see Fungis take their first priority has always been face to face workshops, conferences and sharing of GIS skills. In the last year Exec members have been negotiating for workshops relating to WH&S, Disaster Management and unusual astronomical events – the membership will hear more about these as the new Fungis year progresses.

Critical Spatial Skills

Fungis took the lead in relation to opportunities for funding under the Critical Skills Shortage programme to ensure that those North Queensland practitioners interested in developing their spatial science skills had the best opportunity to do so.

Fungis Executive members formed a Spatial Forum with North Queensland industry groups to identify needs and promote spatial training. Immediate outcomes include: more business
